



In addition to

tax advantages piques the interest of many clients. Strategies vary, including gifts in wills, bequests, or donating marketable securities, each tailored to individual circumstances.

Cash is a common donation method, but not the most tax efficient. For those invested in

stocks, donating appreciated securities can yield substantial benefits. If you have invested in the stock markets over the past 10 to 15 years, you undoubtedly have some appreciated securities with 'pregnant' taxable gains. Simply donate some of those shares and receive a charitable receipt for their full (appreciated) value and pay zero capital gains taxes on them. New AMT rules may impact taxation on donated securities, particularly for those with high incomes and significant capital gains. However, charitable donations included in wills remain unaffected by these changes. The year of death holds tax implications, prompting some to make sizable donations as part of their will to mitigate tax burdens.

Donate Corporately Corporate donations present another avenue for tax-efficient philanthropy. Corporations donating marketable securities can enjoy a 100 percent deduction and avoid capital gains tax. Gains from such donations contribute to the company's Capital Dividend Account, allowing tax-free withdrawals for various purposes.

These strategies enable individuals and corporations to support charitable causes while optimizing tax savings, redirecting funds from taxes to philanthropy.
